

Certificate of Exemption – AGAR 2019/20 Part 2

 - The court has not declared an item of account unlawful after a person made an appeal under section 28(3) of the Act.
- If you are able to confirm that the above statements apply and that the authority neither received gross income, nor incurred gross expenditure, exceeding £25,000, then the Certificate of Exemption can be signed and a copy submitted to the external auditor **either** by email **or** by post (not both).
